

# **Request for Proposals (RFP)**

#### Introduction

The Hague Institute for Innovation of Law (HiiL) invites relevant companies and /or individuals to submit a proposal for conducting a political economy analysis (PEA) on access to justice at the community level in Imo State, Nigeria.

HiiL is currently implementing a multi-year programme in the 6 main regions of Nigeria, focused on developing the different elements of a people-centred justice programme, in close collaboration with the Ministries of Justice, and other stakeholders.

As part of this programme, HilL will execute a Justice Innovation Lab (the Lab) to develop a bankable project proposal for increasing access to justice at the community level in Imo State, Nigeria. The Lab will bring together partners from the public and private sector with the aim of getting commitment from at least 50% of the stakeholders to implement this community justice pilot at scale.

HiiL is looking for a researcher to support the preparatory phases of the Lab through the implementation of a political economy analysis with a view of gaining a better understanding of the drivers and barriers to access to justice at the community level in Imo State, Nigeria.

# HiiL in Nigeria

HiiL (The Hague Institute for Innovation of Law) is a social enterprise devoted to user-friendly justice. That means justice that is easy to access, easy to understand, and effective. In the past 15 years, HiiL has developed a unique data-, research- and innovation-driven approach for delivering our mission. We worked in close collaboration with our national <u>partners</u> to ensure that what we do is closely connected with the national needs, knowledge, and political realities. Nigeria being a vast federation, HiiL has undertaken also a state-by-state approach, as recommended by the local stakeholders.

In Nigeria, HiiL undertook the JNS study in 2018. Findings of the <u>Nigerian Justice Need and Satisfaction Survey 2018</u> focussing on Imo state show that:

- 71% Imo people experienced one or more legal problems;
- 64% of Imo people find their legal problem completely resolved, that leaves 37% without a complete resolution or even anything;
- The most pressing legal problems people face are related to: money, neighbour disputes, employment problems, crime, and housing;
- 87% of Imo people seek information and advice for their problems, mainly through their personal network, less than 20% of the people seeking help go to the formal justice system.

These findings were the foundation of realising a real change 'on the ground'. Based on these findings, a <u>Justice Transformation Lab</u> was conducted in Imo state, Nigeria where a coalition of justice leaders worked on driving innovations that contribute in making justice accessible to all people facing legal problems in their daily lives



# **Objectives of Political Economy Analysis**

- To identify the key power relations, dynamics and trends in governance systems, structures and processes related to people-centred justice in Imo State. This should include overt and covert power brokers, values and norms for decision making, as well as enabling institutions both formal and informal.
- To undertake a stakeholder mapping and power analysis for access to justice at the community level in Imo State with a view to identifying overt and covert power brokers, structures and systems that enable these power brokers, incentives and rewards for the power brokers and the formal and informal institutions enabling the perpetuation of the perceived or real power of these power brokers.
- To identify best practices and lessons learned from existing interventions in the area of access to justice in Imo State
- To identify and highlight the current roles of women, youth, key populations and other groups in decisions and actions related to accessing justice at the community level in Imo State.
- To provide recommendations on both immediate and long term approaches/strategies that HilL and other stakeholders governments, communities, media, researchers, investors and civil society can use to develop sustainable solutions for increasing access to justice

# **Award of contract**
