The panel will trace progress from the 2019 Hague Declaration to the 2023 OECD Recommendation, showing what has worked to make justice systems more responsive to people's needs. Panelists will share national-level insights on implementing people-centred justice approaches, examining regulatory environments that enable or hinder progress. #### **Session 5: Why aren't we scaling?**

This session will tackle one of the biggest challenges in the justice field today: how to scale solutions that we know are effective. Over the years, practitioners, governments, activists and academics have worked hard to identify justice problems and propose viable solutions—with many concrete examples of success. But bringing these solutions to scale remains difficult despite the fact it is essential to enable justice’s potential and promise for economic growth and societal stability.

Speakers will explore the key barriers to scaling: how to secure early political and institutional buy-in, ensure capacity for long-term change and mobilise sustainable funding. This high-level panel of government leaders and funders—including development banks, bilateral donors, and private philanthropy—will identify actionable strategies to expand access to justice at a broader scale
